- (j) a volunteer fire department, rescue squad, or local civil defense organization whose financial oversight is under the control of a local governmental entity;
- (k) any governmental unit of any state or the United States; and
- (1) any corporation:
 - (i) established by an act of the United States Congress; and
 - (ii) that is required by Federal law to submit an annual report:
 - (A) on the activities of the corporation, including an itemized report of all receipts and expenditures of the corporation; and
 - (B) to the United States Secretary of Defense to be:
 - (I) audited; and
 - (II) submitted to the United States congress.

I have read and reviewed the Utah Charitable Solicitations Act (U.C.A. §13-22), and under penalty of perjury, I
hereby certify that the request for exemption and any supporting documentation or information provided to the
Division is true and correct. I also acknowledge that the organization claiming exemption under this section bears
the burden of proving its eligibility for, or the applicability of, the exemption claimed. I understand that any
misrepresentation or falsification contained herein is cause for revocation, and that if I do not comply with the Act
the exempt status may be revoked under U.C.A. §13-12-12.

By signing, I acknowledge that I am required to notify the Division within thirty (30) days of a material change in current legal status, officers, address, phone number, primary contact person, or similar changes and that I shall file a report informing the division of said changes within 30 days of the change. Failure to do so may be cause for revocation of the exemption.
